**HB 1166 Controlled substances; unlawfully obtaining or attempting to obtain, report required.**

Summary as passed House: (all summaries)

Unlawfully obtaining or attempting to obtain controlled substances; report. Provides that any person authorized to prescribe, dispense, or administer controlled substances pursuant to § 54.1-3408 who has reason to suspect that a person has (i) deceived a person authorized to prescribe, dispense, or administer controlled substances from whom he obtains or attempts to obtain a controlled substance or prescription for a controlled

substance, or (ii) failed to report receipt of a controlled substance or a prescription for a controlled substance, may report the activity to the local law-enforcement agency for investigation. Any person who, in good faith, makes a report or furnishes information or records to a law-enforcement officer or entity pursuant to this section shall not be liable for civil damages in connection with making such report or furnishing such information or records.

Summary as introduced:

Prescribing Schedule II, Schedule III, or Schedule IV controlled substances. Requires any prescriber who prescribes a controlled substance included in Schedule II, Schedule III, or Schedule IV of the Drug Control Act to request and review information about that patient from the Prescription Monitoring Program, and to continue to do so at least annually for so long as the prescriber continues to prescribe the controlled substance to the patient.
